Entry instructions and deadlines

### **Jurying**

- 1) Juror will independently screen jpg images of handcrafted wearable art pieces and make the preliminary selection of all work in the exhibition.
- 2) Accepted work is subject to final approval by the juror after the actual work arrives at the Bisbee Fashion Show. Work that differs significantly from what the jpg images represent may be ineligible for the exhibition and may be returned to the artist.

### **Eligibility**

Each artist may enter three (3) pieces.

Exhibit is open to wearable art pieces appropriate for a fashion show. All work must be exhibit quality, completed within the last two years. Work must be one-of-a-kind.

### **Entry Procedure**

All entry fees are quoted in US funds. Three pieces may be entered per fee. Make check or money order of \$15 payable to BFAG and send with completed entry form and signed artist's agreement to BFAG. For each entry, entrants must send two (2) to four (4) jpg images of each piece entered. There must be at least one over-all view and one detail image.

The name on the jpg image should be the name of the piece entered in the fashion show. Do not put your name on the image. The jpg images of the accepted entries will become the property of BFAG and may be used for BFAG promotional purposes. Incomplete entry forms will be returned to the artist.

### **Presentation of Work**

All accepted entries must be sent ready to model.

### **Awards**

First, second and third place awards will be selected by the juror. Additional special criteria awards may be available. Awards are as follow:

First \$300

Second \$200

Third \$100

**Calendar**

Any entries received after the deadline of February 14, 2012, will be returned unopened.

Datelines are as follow:

- Application and jpg images must be received by February 14, 2012.
- Jury notification sent: February 21, 2012
- Accepted pieces must be received by March 15, 2012.
- Fashion show is March 31, 2012, 3:00 P.M.
- Return of work: after March 31, 2012.

**Sales**

Fashions on exhibit can be offered for sale.

**Shipping**

Shipping instructions for accepted work will be sent with acceptance notification.

Artists are responsible for the cost of sending and return shipping of their work and for insurance during transit. It is the artist's responsibility to provide check or money order to cover all shipping costs.

**Liability**

*All possible care will be taken with accepted garments, but Bisbee Fiber Arts Guild is not liable for any loss or damage to garments.*

**Return:**

- Completed entry form with signed artist's agreement
- Two to four jpg images with only the title of piece on the image
